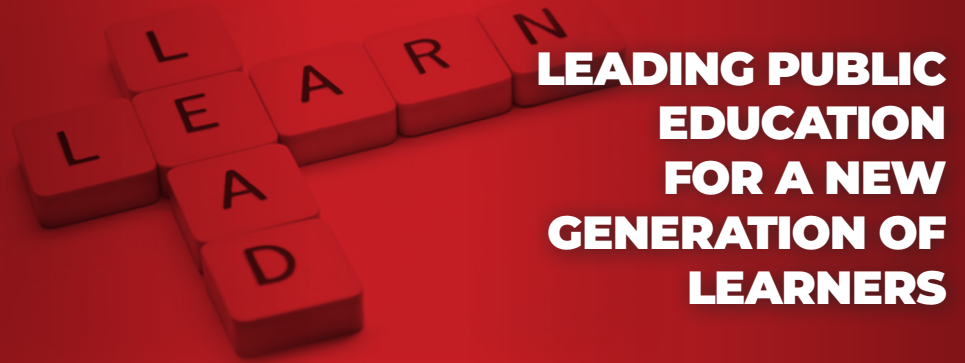

Michele tells her personal story and recounts the lessons she learned on December 14, 2012 and across the aftermath of the Sandy Hook School tragedy. She shares the inspiring way she has chosen to help school communities improve school safety in honor of her daughter, Josephine, and in memory of the other 19 children and six teachers lost on December 14, 2012. Michele's perspective as a parent provides unique insight and inspiration for parents, administrators, school staff, emergency responders, and community members who strive to make their schools safer.

With a Bachelor of Science in Elementary Education from Towson State University, Michele earned a Master's degree in Curriculum and Instruction from McDaniel College. Prior to the Sandy Hook tragedy, she taught at the elementary level in the Maryland and Virginia public schools. As an educator, mother, and survivor of tragedy herself, Michele is uniquely positioned to help others. She has dedicated her life to honoring Josephine's memory by ensuring that every school, every child, and every community is truly safe and sound.

KEYNOTE: TELL ME SOMETHIN' GOOD! PERSONAL ENGAGEMENT IN A POST-PANDEMIC WORLD

The global pandemic has changed so many things. It has changed the way we work. It has changed the way we learn. It has changed the way we buy. It has changed the way we interact with each other. As we make our way to the other side of this pandemic, we have the ongoing challenge of staying engaged in our work. Quite frankly, staying engaged in a pre-Coronavirus world was a challenge. With research showing two-thirds of employees were showing up to work each day prepared to do the minimum to get by, employee disengagement was a source of ongoing frustration for all organizations. Without question, employee engagement starts with personal engagement. We all have a responsibility to focus on personal engagement because every day we show up to work we are either adding to or taking away from the culture of the organization. There is no middle ground. Our personal engagement is our daily contribution to a culture of employee engagement. In this keynote session, we'll take a look at some simple things we all can do to enhance our personal engagement while helping others add to a culture of employee engagement within Indiana school districts!

After a period of instability in district governance, NPUSC has benefitted from more than two decades of stability at the school board level, which has brought stability to the Superintendent leadership. NPUSC leaders will share lessons learned on the journey to becoming one of Indiana's most consistent governance-executive situations. Practical strategies to develop trust, accountability, and collaboration between the School Board and Superintendent will be shared.
